What did we achieve?

For the eleventh year now, Buildings for the future (B4F) has continuously worked on improving public policy approaches to the buildings sector in Slovakia. As the largest Slovak professional interest group representing the construction and renovation industry in policymaking, we worked to ensure the continuity of government assistance schemes for home improvements and renovations. The programme "Obnov dom" [1] has been operational for two years now. Throughout 2024, the Slovak Environment Agency [2] managed to expedite its project evaluation process for incoming subsidy/grant applications.

The support schemes set up for **renovation of public buildings** show that the absorption capacity of the construction sector significantly exceeds the volume of funds available through the support schemes. The key to B4F's success in the year 2024 was our ability to **communicate** in a manner that is **consistent**, transparent and comprehensible, to conduct professional analyses, to formulate arguments supported by data and our ability to act as a mediator between the private sector and government institutions, which led to concrete recommendations to policymakers.

Our core values are professionalism, political neutrality, attention to facts and detail, and transparency.



Our biggest success stories in 2024



Establishing connections across the sector for the future of buildings – together we can achieve more We initiated an **open letter to the Slovak government** which has since been supported by 33 business entities and associations. It has shown itself to be one of the ways of communicating our interests to the members of the new government and to get the government's attention for the issue of energy efficiency. Thanks to the open letter, we were able to hold talks with the Ministry of Transport and the Ministry of Economy of the Slovak Republic.

We encouraged the government to invest in the renovation of buildings and in measures enhancing the energy efficiency of buildings, which could over time lead to a decrease in energy costs, improve the standard of living and stimulate economic activity. Together with signatories we emphasised the need for a thorough and proper implementation of the relevant EU legislation pertaining to energy standards in buildings and for the allocation of sufficient volumes of funds to the renovation of buildings and to training programmes teaching in-demand skills for the labour market.

Moreover, we **proposed the establishment of a coordination platform which would facilitate the collaboration of all relevant stakeholders.** Such multilateral cooperation aims to support a sustainable renovation of buildings that leads to energy savings, creation of new job opportunities, development of the construction sector and ultimately contributes to economic growth and to the fulfilment of climate targets of the Slovak Republic.



Our biggest success stories in 2024



We organise public events and enable discussion on issues, which otherwise would not appear in public discourse

We organised a conference on energy efficiency and energy savings in buildings that brought together **110 participants and 15 speakers** working in public administration, EU agencies, and in the private sector.

The event took place under the auspices of several government agencies, and it underlined the importance of collaboration through public-private sector partnerships to achieve the building renovation targets. The aim of this conference was to identify opportunities for accelerating the rate of renovation of public buildings to ensure compliance with the targets set in the Energy Efficiency Directive (EED) and the Energy Performance of Buildings Directive (EPBD).

In the closing remarks of the conference, the participants jointly expressed a need for legislative stability, technical support, and effective private sector participation to safeguard timely progress on the existing targets.



Our biggest success stories in 2024



We foster partnerships and build bridges between stakeholders at the regional level

We concluded several key **Memorandums of Cooperation** at the level of selfgoverning regions and municipalities of Slovakia. Through our cooperation with the Bratislava Self-Governing Region (BSK) we seek to create a framework for effective and deep renovations of buildings owned by BSK through pilot passports which offer a long-term plan to improve the energy performance of buildings, bring down associated costs and decrease greenhouse gas emissions. The cooperation with BSK presents a viable model for municipalities and specialised organisations planning to renovate buildings and to improve their energy performance.

As a result of B4F's partnership with BSK, **renovation passports for two public buildings in Bratislava were drawn up – a Business College on Dudova street and a social service facility in Rača.** Collaboration with the SK8 association and ZMOS is aimed at the intensification of renovation of public buildings, increasing their energy efficiency and support sustainable solutions which improve the quality of the indoor environment and will deliver long-term savings.

We published 7 position papers and analyses. Our study titled "How to ensure the mandatory renovation of 3 % of buildings owned by public bodies every year up to the level of NZEB/A0?" has brought concrete recommendations for meeting the objectives of EU-legislation and presents the next step toward a systemic renovation of buildings in Slovakia.

B4F organised 4 expert roundtable discussions on EPBD and 6 public events, both online and in-person. The Slovak climate initiative (SKI) contributed by organising 5 discussions within the series "A green vision for Slovakia" and the conference titled Energy of the future, which leaves no one behind, which was ceremonially opened by the Slovak President, Mr. Pellegrini.

We were involved in the inter-departmental review of 3 separate materials as they were introduced in the legislative process. Furthermore, we were able to push through a fee exemption for water-to-water heat pumps. The amendment to the Water Act which passed in April 2024 exempts water-to-water heat pumps from a special fee for the energy use of surface water and groundwater is a major milestone that facilitates the use of green technologies in Slovakia. We participated in 85 work meetings including talks with State Secretaries, the Director General of the Slovak Environment Agency (SAŽP), and the Director General of the Slovak Innovation and Energy Agency (SIEA).

Lastly, we sustained a notable media presence throughout the year, producing almost 300 media releases.

Our priorities for 2025

Ambitious and proper implementation of EU-legislation

Two key directives – **the EPBD, and the EED** – are to be transposed into national law, with some fundamental consequences for the Slovak economy and its competitiveness and for Slovak households. Slovakia is facing major decisions that will affect the buildings sector at least until 2035. The government will be taking steps which may substantially expedite the building renovation rate, increase the depth of renovations and set conditions favourable to a decarbonisation of the building stock. Among the key objectives of the EU directives are increasing the renovation rate of buildings, creating a stable investment environment, and helping residents save energy.

To attain these objectives, properly set and functioning financial support schemes are necessary. These would also enhance the quality of housing and bring down energy costs for households. Therein lies a unique opportunity for Slovakia to use the directives as a tool by means of which to attain a higher living standard, become more economically competitive and promote sustainability. At B4F, we will try our best to ensure that the government defines and implements measures that will put the building stock on the right trajectory.



Our priorities for 2025

Sustainable financing and functioning support schemes

its budget available for allocation.

It is expected that at the present rate of depletion, the available budgets will run out in the year 2025, despite having been intended to satisfy demand for renovation up until 2027. Our role is to publicly talk about the need to replenish the budgets of active support schemes and to work towards a political decision being made to satisfy this end.

In the **Obnov dom** programme more than 75 % of all available funds have been allocated or are bound to be allocated based on incoming applications. Support scheme budgets for the renovation of public buildings for which funds were meant to be available up until 2027 have already been exhausted. The pending applications exceed the available funds by about 770 million euros. The Green light for households programme has also been in high demand, leaving only some 40 % of
